The above persons, who are associated with OFAC-designated Rayan Roshd Afzar Company (RRA) that have procured critical parts for Iran's unmanned aerial vehicle (UAV) program, were designated pursuant to Executive Order (E.O.) 13382, which targets proliferators of weapons of mass destruction (WMD) and their means of delivery.

As a result of OFAC's action, all property and interests in property of the designated persons, or any entities that are owned, directly or indirectly, individually or in the aggregate, 50 percent or more by one or more blocked persons, that are in the United States or in the possession or control of U.S. persons are blocked and must be reported to OFAC. Unless authorized by a general or specific license issued by OFAC, or exempt, OFAC's regulations generally prohibit all transactions by U.S. persons or within (or transiting) the United States that involve any property or interests in property of designated or otherwise blocked persons.

In addition, financial institutions and other persons that engage in certain transactions or activities with the sanctioned entities and individuals may expose themselves to sanctions or be subject to an enforcement action. The prohibitions include the making of any contribution or provision of funds, goods, or services by, to, or for the benefit of any designated person, or the receipt of any contribution or provision of funds, goods, or services from any such person.

The above companies, which are linked to the Private Military Company "Wagner" (Wagner Group), are being designated pursuant to Executive Order (E.O.) 14024 for enabling Wagner Group security operations and Wagner Group-linked illicit mining endeavors in the Central African Republic (CAR).

As a result of OFAC's action, all property and interests in property of the designated persons, or any entities that are owned, directly or indirectly, individually or in the aggregate, 50 percent or more by one or more blocked persons that are in the United States or in the possession or control of U.S. persons, are blocked and must be reported to OFAC. Unless authorized by a general or specific license issued by OFAC, or exempt, OFAC's regulations generally prohibit all transactions by U.S. persons or within (or transiting) the United States that involve any property or interests in property of designated or otherwise blocked persons.

In addition, financial institutions and other persons that engage in certain transactions or activities with the sanctioned persons may expose themselves to sanctions or be subject to an enforcement action. The prohibitions include the making of any contribution or provision of funds, goods, or services by, to, or for the benefit of any designated person, or the receipt of any contribution or provision of funds, goods, or services from any such person.

## C. <u>Publication of Amended Cuban Assets Control Regulations (CACR) and Related</u> <u>Frequently Asked Questions</u>

On the 29<sup>th</sup> May 2024, OFAC announced that it is <u>amending the Cuban Assets Control</u> <u>Regulations, 31 C.F.R. Part 515 (CACR)</u> with the purpose, among other things, to increase support for internet freedom for the Cuban people and independent Cuban private sector entrepreneurs by expanding authorizations for internet-based services and a range of financial transactions.

In particular, OFAC amendments provide additional examples of authorized services incident to the exchange of communications over the internet and to include and expand certain services to support the exchange of such communications.



Furthermore, they authorize independent private sector entrepreneurs in Cuba, to maintain and use a U.S. bank account to conduct authorized or exempt transactions.

The rule will be published in the Federal Register on Wednesday, May 29, 2024.

Furthermore, OFAC is issuing six new, Cuba-related Frequently Asked Questions (<u>FAQs 1174-1179</u>) and amending eight Cuba-related Frequently Asked Questions (<u>FAQs 732, 736, 745, 748, 757, 769, 770, and 785</u>).

**FAQ 1179** explains that the term "independent private sector entrepreneur" means a Cuban national who is not a prohibited official of the Government of Cuba or a prohibited member of the Cuban Communist Party, and who is (a) an owner, including a self-employed individual, or employee of a small private business entity, private cooperative, or a sole proprietorship located in Cuba; (b) an independent contractor or consultant; (c) a small farmer who owns his or her own land; (d) a small usufruct farmer who cultivates state-owned land to sell products on the open market; or (e) a private cooperative or small private business entity located in Cuba.

## FAQ 1179

**FAO 1178** states that Section 515.582 of the CACR authorizes persons subject to U.S. jurisdiction to import certain goods and services produced by independent private sector entrepreneurs, as determined by the State Department.

In determining whether a good is produced by an independent private sector entrepreneur, persons subject to U.S. jurisdiction should consider the extent of Cuban state-owned entities' involvement in the production and exportation of such goods.

## FAQ 1178

<u>Amended FAQ 732</u> explains that <u>Section 515.570</u> excludes f.rom the scope of the authorization of remittances any transaction relating to the collection, forwarding, or receipt of remittances involving any entity or subentity identified on the <u>State Department's Cuba Restricted List</u> and lists a number of categories of allowed remittances from persons subject to U.S. jurisdiction to persons in Cuba.

#### FAQ 732



<u>Amended FAQ 736</u> states that persons subject to U.S. jurisdiction may engage in transactions in U.S. dollars in Cuba or with Cuban nationals with respect to activity that is authorized pursuant to the CACR.

OFAC expects U.S. banks, including their foreign branches and subsidiaries, to conduct due diligence on their own direct customers (including, for example, ownership structure (for entities), proof of citizenship (for individuals), and address information to confirm that the transactions being processed are consistent with the U-turn general license.

## FAQ 736

<u>Amended FAQ 770</u> states that, pursuant to <u>31 CFR § 515.582</u>, certain goods and services produced by independent private sector entrepreneurs, as defined in <u>31 CFR § 515.340</u>, and as set forth in a list maintained by the <u>State Department on its website</u>, are authorized for importation. Persons subject to U.S. jurisdiction may engage in associated transactions necessary to import these authorized goods and services. The <u>State Department Section 515.582</u> list provides details of the goods and services authorized for importation into the United States from Cuba pursuant to this provision.

As a result of OFAC's action, all property and interests in property of the designated individuals and entities that are in the United States or in the possession or control of U.S. persons must be blocked and reported to OFAC. OFAC's regulations generally prohibit all dealings by U.S. persons or within the United States (including transactions transiting the United States) that involve any property or interests in property of a blocked or designated entity.

In addition, persons that engage in certain transactions with the entity designated today may themselves be exposed to designation.
